	b) Self declaration form in the prescribed format (Template of Self Declaration form can be downloaded from web portal).
	c) Authorization letter in case of Partnership firm/ Company. (In case of Partnership firm, the Authorised signatory shall be one of the partner)
	 d) Self attested copy of Firm/ Company address proof document e) Self attested copy of valid Electrical Contractor License issued by the Labour Department, Govt. of NCT of Delhi.
	f) Dissolution deed in case of dissolving firm from Partnership/Company into Proprietorship.
