## FAQ in r/o Grading of Guest House

**Introduction**: This scheme is designed to accord status to the registered guest houses which are maintaining high standards. Grading will be given only to those guest houses, who are following the prescribed guidelines and have undergone a procedure of inspection and evaluation. This is a **purely voluntary scheme**.

1	Who is eligible for Grading of Guest House?	Only those guest houses, which have valid license/registration from Local bodies/Police/Fire Department shall be covered under this scheme.
2	On what basis the Guest Houses are categorized?	The Guest Houses are categorized for the following classes:- (i) Standard Category (ii) Premium Category (iii) Luxury Category . On the basis of standard being maintained and facilities / services being provided to the Tourists / Guests.
2	Is it mandatory to obtain Grading of Guest House from Tourism Department?	Grading of Guest Houses by Tourism Department is a voluntary scheme. However, the Certificate issued by Tourism Department can be used by Guest Houses to their advantage to attract Tourists/Guests.

5	What is the validity of certificate once issued?	05 years from the date of issue of certificate.
6	After its expiry what fees will be charged?	In case a person applies, at least three months before the expiry of the current approval, the application fee would be charged @50% of the regular fee and the renewal in such cases shall be effective from the next day of the date of expiry. i.e. continuity will be maintained. If applied otherwise, regular fees would be charged.
